I asked him why he did that and he told me his doctor told him to do it because he needed to have feeling around his penis. He had a hole in the crotch of the same Sweatpants (they were green) and on a few occasions he would masturbate himself likite ciriving me home. He told me one time that his doctor told him the reason he had this "illness" is because he didn't masturbate enough when he was a kenager. I lived with this terrible secrect until I was 19 years old. On October 12, 1996, I finally found the courage to let people know of the innocence His pedaphile Stale from me. Unfortunately, the Statute of limitations had run out 52 days carlier. I was told by Randy Constantine, a La salle County DCFS invistigator that Derek had confessed to his criminal acts in a 6 page interview, but there was nothing they could do because of the Statutes of limitations. It is a shame this pedophile walks away quictly and appropriate when confronted with the facts. I will do allything in my power to keep this pedophik away from innocent children.
